Jennifer Farwell discussed the option of Cremation as a choice of final tribute to a loved one.

While it may be thought that Cremation is a less expensive choice, we were told that the cost is very similar to traditional burial services.

The service can be virtually the same as a more traditional service, including a viewing of the loved one, in a casket, with Cremation to follow.

Remains can be scattered, placed in an Urn that could be located in your home, or placed in a Niche for a permanent memorial, or

they can be buried like a traditional casket.

We learned that each cemetery has their own regulations regarding burial, so the family needs to consult with the Funeral Home for the proper procedure.

Jennifer explained that the final disposition of the remains is the decision of the next of kin. It is important that the wishes of the deceased be discussed and made known to the family so they can consider that wish when final arrangement is made.
